#### Speakers

*MC- Maria Dimopoulos:* is nationally and internationally recognised as an expert specialising in the intersections of diversity, gender equality and the law. In 2008, she was appointed by the Federal government to the National Council to Reduce Violence Against Women and their Children. Maria currently sits a number of government and non government committees and is the Chairperson of the Harmony Alliance - Australia's national coalition of migrant and refugee women and a member of the National Women's Alliances. In 2017 Maria was presented with the Lifetime Achievement award by the Migration Council of Australia for her tireless devotion to Australian multiculturalism and support for Culturally and Linguistically Diverse women. She was inducted into the Victorian Honour Roll of Women and is a recipient of an Amnesty International Human Rights Award for her work on the legal needs of women from non English speaking backgrounds.

#### **Dr Wendy Bunston**

Wendy Bunston currently works as a senior clinical consultant and trainer with wb Training and Consulting as well as an associate lecturer in the Department of Community and Clinical Allied Health, La Trobe University. Wendy does research in Social Work, Infant and Child Mental Health, Family Violence and Group Work. Her award winning PhD thesis was titled; 'How Refuge provides 'refuge' to Infants: Exploring the experience of the infant in Women's Refuges.' She is currently preparing her second book with UK publisher JKP, called Supporting Vulnerable Babies and Young Children, How to Work with Complex Challenges', with co-editor with S.J. #### Elena Campbell

Lawyer, former political staff writer and legal consultant, Elena Campbell has worked in social and justice policy for twenty years. Now Associate Director a the Centre for Innovative Justice, Elena leads a program or research into family violence, with a particular focus on perpetrator interventions, young people's experience and use of violence. Court processes which respond to family violence an the way in which experiences of violence can propel people into criminalisation.

#### **Carmel Guerra OAM**

Carmel Guerra is the founder and Chief Executive Officer of Centre for Multicultural Youth (CMY), the first organisation in Australia to work exclusively with migrant and refugee young people. Carmel is also the Chairperson of The Multicultural Youth Advocacy Network Australia (MYAN), the national peak body representing multicultural youth issues. Carmel is recognized for her commentary on multicultural youth issues. She has served on numerous boards and committees and is currently a member of the Youth Parole Board of Victoria, the Victorian Children's Council, the Migration Council of Australia, and the Settlement Services Advisory Council. Carmel was awarded a Medal of the Order of Australia in 2016 for services to multicultural youth in Victoria and was the recipient of a Centenary Medal for services to migrant and refugee communities

Mehak Sheikh is a passionate, proactive and motivated young woman, who moved to Melbourne with her family in 2012. As a psychology student, Mehak is interested in behaviour and wants to work with children, young people and businesses.
